Deadline is on Hold – Due to legal action

In light of a recent federal court order, reporting companies are not currently required to file beneficial ownership information with FinCEN and are not subject to liability if they fail to do so while the order remains in force. However, reporting companies may continue to voluntarily submit beneficial ownership information reports.



EX: SAVEQ- Spirit Airlines was .15 cent Nov 19th .90 cent Dec 6 .68 cent Dec 13

That is 400-600% Rate of Return

Math it- $90 \div 15 = 6$ times ROR or 600%- Dec 6Math it- $.68 \div 15 = 4$ times ROR or 400%-Dec 13
